

Terms & Conditions T&C-V130 (Terms & Conditions for Kono Magazine Free Trial Service)

1) Your Acceptance

1.1 This is an agreement between SmarTone Mobile Communications Limited ("SmarTone" or "the Company") and you ("you" or "the Customer"), a user of "Kono Magazine" ("the Service"). BY USING THE SERVICE, YOU ACKNOWLEDGE AND AGREE TO THESE TERMS AND CONDITIONS. If you do not agree to any of these terms and conditions, you may not use the Service.

2) Service Plan

- 2.1 The Service is only available to customers who have subscribed the Company's mobile telephone services.
- 2.2 The Service operated by Kono Digital, Inc.(USA) Taiwan Branch ("Kono Digital") is a digital reading platform that provides a subscription service for online magazines and allows customers to download and stream magazines through supported devices and personal computers ("PC")
- 2.3 The Customer shall use the following Service Plan as specified in the Sales and Services Agreement:

Kono Magazine	Two Months	HK\$38

- 2.4 The Service Plan is charged on a monthly basis. The monthly charges are non-refundable under all circumstances.
- 2.5 Dedicated customers can subscribe to and enjoy the above Service Plan once only.
- 2.6 The Kono Magazine service will be automatically terminated when the Term expires. Customers must subscribe to the Kono Magazine Service Plan to use the service.
- 2.7 Usage of the Kono Magazine service will incur data. These charges will be deducted from the relevant subscribed service plan and charged at the applicable fee thereafter. Alternatively, usage will be charged based on standard data charges.
- 2.8 The usage rules established by the Company relating to the Service may be controlled and modified by the Company for compliance purposes. The Company reserves the right to enforce such usage rules without prior notice to the Customer.

3) Rebate

3.1 Customers who have subscribed to the Service Plan specified in Clause 2.3 shall be entitled to the following rebate.

- 3.3 The Credit Amount (OR The Rebate Amount) paid by the Company will only be applied by the Company to meet the Customer's payment obligations to the Company in respect of the Customer's Account. However, the Customer cannot set-off any other sum payable to the Company against any part of the Credit Amount (OR Rebate Amount) payable by the Company to the Customer's Account.
- 3.4 The Credit Amount (OR The Rebate Amount) cannot be exchanged for cash.



- 3.5 The Company shall not be under any obligation to pay any interest to the Customer on the Credit Amount (OR the Rebate Amount).
